- SIS Integrations

Thanks to all the responses for IT contacts, I emailed them the first SIRAS SIS integration update just before I emailed you.

For HS districts, please ensure all your HS Diploma graduates that aren't returning have their SWDS effective date adjusted to one day after the actual graduation date (SENR enrollment exit date) in CALPADS only. Exit summaries can be done the same way in SIRAS with no change.

- DRDP

DRDP ratings were due into SIRAS at the end of May, but we still have some districts with many missing.

Please use the predefined query under statewide assessment of 'DRDP not started or Incomplete' to find them.

DRDP ratings not complete or with remaining errors by the last week of June may need to be removed to certify your SELPA data as a whole.

DRDP errors will be updated the morning of 6/12 and again the morning of 6/17, or upon request.

- End of year initials

For any students with parental consent for assessment prior to 7/1 and meeting will be after 6/30, please archive a pending meeting archive as soon as the parental consent date is obtained, if there is no SSID yet, your LEA is required at that time to obtain one.

For any students having an Initial on or prior to 6/30/2025 we need to close the meeting prior to LEA Approve to report the results of the meeting.

If they are found eligible but won't be participating until next year, for sure close them as eligible no plan/future start date.

Then when they return in Fall, we make them active and archive a plan adoption. SIRAS will automatically send the SWDS 1 at that time in addition to the plan and service records.
