


For each of the added CALPADS elements below, SIRAS Systems will be adding appropriate changes into the SIRAS program accordingly:

CALPADS is adding the following field elements to the PLAN file:

- [23.34] Part C to B Transition Conference Date
- [23.35] Part C to B Transition Plan in IFSP Indicator

- SIRAS IFSP Staff will continue to use the ‘**Annual**’ meeting type with secondary purpose of **Transition Planning**.
- When the annual review is setup this way, SIRAS will report the meeting date as the transition conference date and report the new **transition plan in IFSP Indicator**.
